Dear Mr. LaPorta:

Thank you for your correspondence concerning Bank of America. As you may know, on behalf of the state of Nevada, the Attorney General's Office filed a lawsuit against Bank of America. Our office alleged that Bank of America violated the Nevada Deceptive Trade Practices Act. The State seeks to cease the party from engaging in illegal practices and to obtain other equitable relief for consumers.

Nevada's recent lawsuit against Bank of America does not affect your legal obligations or your rights. This means the filing of the lawsuit does not excuse you from making loan payments under the terms of the loan agreement. Furthermore, the Attorney General's lawsuit does NOT stop or undo a foreclosure. Our lawsuit does not preclude you from bringing your own action against the defendant(s). You are advised to contact a private attorney or HUD approved counseling agency about your loan.

Despite our efforts to move cases expeditiously, the legal process usually requires considerable time to complete. We ask for and appreciate your patience. From time to time, we may ask you for assistance. Please be advised that we are unable to return phone calls; we request that all complaints must be in writing. When the lawsuit is complete, we will notify you of the outcome.

Please keep in mind that this office represents the state of Nevada and not individual consumers; thus cannot act as a private individual's attorney and cannot provide legal advice to private citizens.
